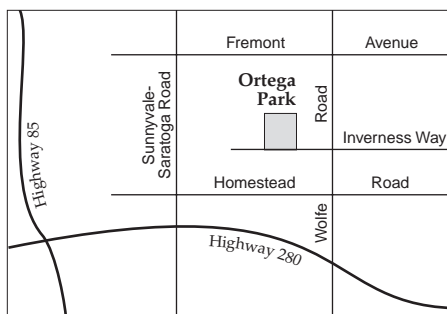

## Annual Wine Tasting, Family Picnic and Awards Ceremony

The Santa Clara Valley Section will hold its annual Wine Tasting, Family Picnic and Awards Ceremony on July 10th (Saturday) at Ortega Park in Sunnyvale. Ortega Park is a family-friendly park located on Inverness Way, off of Wolfe Road. The park has picnic tables in the shade and grassy areas for playing Frisbee or catch with the kids. The park also has a playground and a water sprinkler. Wine tasting will begin at 4:30 PM followed by a self-serve buffet starting at 5:30 PM. Wine tasting will feature the wines of Fenestra Winery. Recognition and Awards (50 year members) for

the Santa Clara Valley Section will follow dinner. The price for the dinner will be \$10 for Section members. Each member may bring one non-member at the \$10 price. Additional members are \$15 and children aged 4 to 12 are \$5. The money must be paid before the picnic; we are not allowed to accept money at the park. Dinner is free for children under 4. This is an informal, serve-yourself family picnic. You are welcome to come early with the family to enjoy the park until the picnic starts.

A main function for a professional organization is to address its members' career growth and needs. The American Chemical Society, on the local and national level is striving to meet those needs. The objectives of this program are:


1. Develop and implement a local career program that empowers local sections to deliver career assistance and collect and disperse information on employment trends and issues.

## FENESTRA WINERY

Fenestra Winery was established in 1976 by the Replogle family on the historic Ruby Hill property and in 1980 occupied the century-old George True Winery building on Vallecitos Road. The old building had been badly neglected, and the Replogles installed a new roof and strengthened the building. Now part of the Ruby Hill development, the Replogles lease the newly refurbished building and surrounding grounds, which are nearly surrounded by 900 acres of vineyards from the Ruby Hill development. The winery specializes in classically balanced, award-winning wines from primarily Livermore Valley grapes. The owners are Lanny and Fran Replogle.

The winemaker is Dr. Lanny Replogle, Ph.D., who is now Professor Emeritus of Organic Chemistry, San Jose State University.

My aim is to produce flavorful, well balanced wines with a lot of varietal character. Of the whites, I particularly enjoy making Semillon, and a dry table wine blend of Semillon-Chardonnay (Semonnay). I make a lot of red wines, from True Red (a blend) to full-bodied intense Cabernets, and like the challenge of making each varietal, each year, an individual wine.

Wines that are produced are: Semillon, Semonnay, Pinot Gris, Chardonnay, True Red, Zinfandel, Merlot, Cabernet Franc, Cabernet Sauvignon, Sangiovese, Petite Sirah, Port, Syrah, Mourvedre. Production is 6500 cases.

# State Capital Day

It was a long day. It was an interesting and exciting day. It was California State Capital Day, April 28, 1999. It began at 6:30 AM when Jamil Talhouk, Art Diaz, Cam Ainsworth, Sally Peters, Donna Mena and Carol Mosher started the drive to Sacramento (They were joined there by Richard diPietero, Joe Bunnett and Mrs. Bunnett). Upon arrival at the Hyatt Regency Hotel, they were greeted by Patricia Vrabel from the Legislative and Government Affairs Office of the American Chemical Society. She and her staff had done a superb job in planning and arranging the day's activities, the intent of which was to inform legislators about the policies of the ACS and willingness to provide information to them about issues they wished to discuss. In addition to our Santa Clara Valley Section members, members from other California sections were in attendance, a total of about 30 individuals.

During the morning, brief talks were given by Deputy Superintendent Sonia Hernandez (California Department of Education), Assemblyman Bill Campbell, (Vice-Chair, Assembly Committee on Education) and Assemblywoman Hannah-Beth Jackson (Chair, Assembly Committee on Environmental Safety and Toxic Materials) and Dona Mena (Chair, Northern California MTBE and Fuel Oxygenates Committee). Each speaker presented very interesting information about the status of bills on Education or Environmental affairs and had time to answer a few questions.

After lunch Senator Deidre Alpert (Chair, Senate Committee on Education) gave a more detailed review of the problems facing our schools and some of the proposed solutions, including requiring students to pass a final exam before receiving a high school diploma, publishing results of using estab-

lished standards plus attendance records on schools relative standings, and peer review of teachers' performances.

During the rest of the afternoon, the ACS members, in small groups, met with individual legislators. All of the SCVS members met with their Senator, Byron Sher; interestingly, he expected that the ACS was "lobbying" on some issue and was pleased to receive information about the ACS policies in regard to education and environmental affairs. Other legislators (or in several cases, their aides) that were vis-

ited included Assemblymen Jim Cunneen, Mike Briggs, Anthony Villaraigosa, Howard Wayne and Senators Theresa Hughes, John Vasconcellos. All of the legislators were given literature on Public Policy Priorities of the ACS.

It was a most interesting and rewarding day for those who were able to attend the first State Capital Day in California. Ten other states will have similar days this year, and the hope is that in future years more states will also do so. The national ACS office is ready to make the necessary arrangements; members from the local sections must participate. A wonderful experience!

## Notes from the 217th Meeting of ACS

March 20-25, 1999 in Anaheim, California

Your six Santa Clara Valley Section councilors attended the Council meeting and were also busy working on several committees on Saturday and Sunday. Highlights that they reported include the following:

Attila E. Pavlath and Alan Schriesheim were selected as candidates for President-Elect in 2000. ACS members will select one by ballot vote in the fall.

As announced on Wednesday morning, registration for the meeting was 10,517 with 13,042 in attendance, including exhibitors; more than 5100 papers were presented in the various divisions.

In the National Employment Clearing House, 1400 jobs were posted; 1020 job seekers were interviewing for those jobs

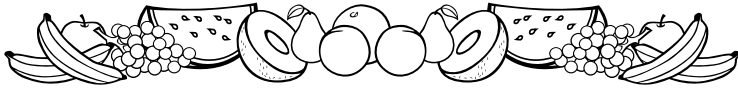
A motion from the committee on Meetings and Expositions at the National meeting in Boston in August, 1998 that the fee for advance registration to National meetings in 1999 be raised to \$235 failed to pass in the Council (in Boston). However, the Board of Directors chose to override the Council and therefore the registration fee for both of the 1999 National meetings were \$235. The national meetings have been operating in the red and the projected deficit in the future is growing; the increase in registration fee is just one of the measures considered to reduce the deficit.

The current dues of \$105 have been raised to \$108, as mandated by the escalation rate.

An endowment fund for National Chemistry Week has been established; to date 80% of the necessary funds have been pledged.

A motion that the national meeting in March 2009 be held in Salt Lake City was seconded and passed.

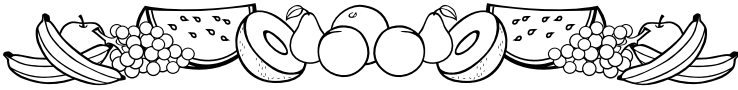


## Editor's Corner
